Skyrocketing Costs for EMS Providers in Rhode Island

Although reimbursement from Medicare and other payers remains stagnant, ambulance mobile healthcare providers are facing skyrocketing costs. Many ambulance services struggle to keep their doors open.

Access to care is threatened as Medicare rates remain stagnant despite rising costs. EMS needs YOUR support to keep services rolling.

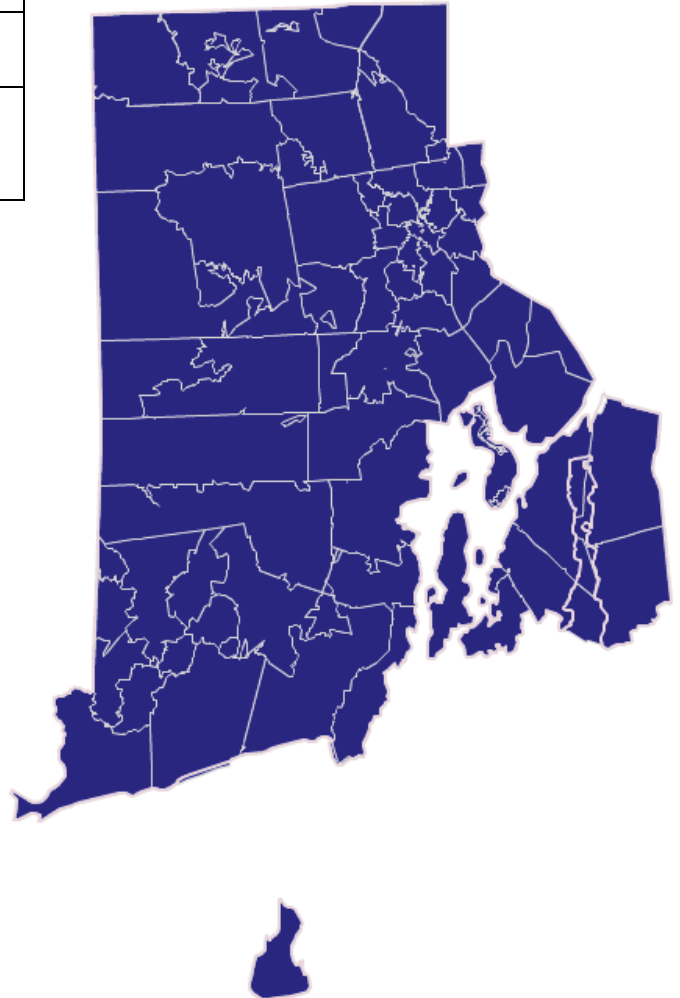

Medicare Add-Ons are Essential

The Medicare Ambulance Add-Ons are critically important to ambulance suppliers/providers in Rhode Island. The map shows that while there are urban areas in the state, a substantial number of ambulance providers are in rural areas and super rural areas. All ambulance providers in Rhode Island rely upon these add-ons.

Ambulance Deserts: 71.4% of Rhode Island Counties Impacted

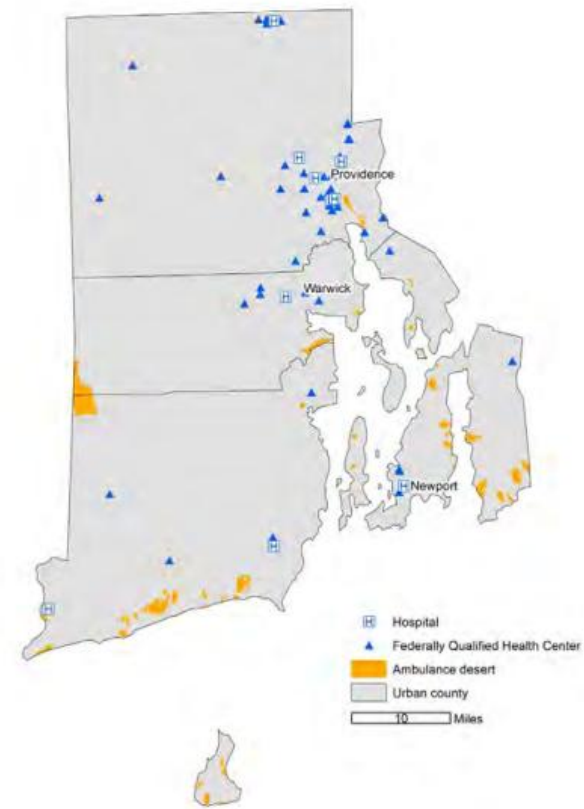
